- Ⓢ Dogs are permitted in hotel rooms only. Dogs are not permitted in Condo units or in our Morningside Villas.
- Ⓢ Please keep your dog on a leash or in a carrier while in public areas.
- Ⓢ Please keep your dog out of all indoor food & beverage areas, pool and hot tub areas, Convention Center and the golf course. Our dog friendly food & beverage areas are Saddles Deck and Sevens Deck.
- Ⓢ Please be present while any team member of the hotel staff, such as housekeeping or engineering, is in your room. We welcome you to pre-schedule your housekeeping services in order to further enhance your comfort as well as the comfort of your four-legged companion.
- Ⓢ Please keep your dog with you or a designated individual at all times and do not leave him/her unattended in the room.
- Ⓢ Please prevent noise or any other disturbance by your dog, in the interest of other hotel guests.
- Ⓢ Please note, the Sheraton Steamboat Resort reserves the right to add any additional cleaning or repair fees should they be required and the hotel is authorized to charge your credit card for such charges, even if they are discovered following your departure from our resort.
- Ⓢ Also, please note, should your dog create any disturbances, which would cause complaints made to the hotel by other guests, at the request of the hotel manager, you could be asked to make alternative arrangements to house your dog elsewhere outside the hotel.
- Ⓢ Please be aware that Sheraton Steamboat Resort reserves the right to charge your guest account for any compensation deemed necessary to other guests as a result of disturbances from your dog.
